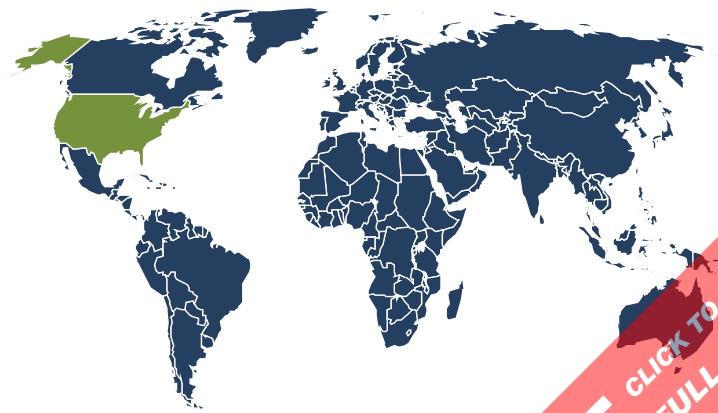

ABOUT THIS REPORT

Scope & Method

This report forecasts US ketone solvent demand in pounds and US dollars at the manufacturers' level to 2020. Total demand in pounds is segmented by product in terms of:

- acetone
- methyl ethyl ketone
- methyl isobutyl ketone
- other products such as methyl amyl ketone, methyl propyl ketone, and diisobutyl ketone.

Total demand in pounds is also segmented by market as follows:

- paint and coatings
- adhesives and sealants
- plastic and rubber processing
- printing inks
- cosmetics and toiletries
- other markets such as chemical processing, construction, and petroleum refining.

To illustrate historical trends, total demand in both value and volume terms is provided in annual series from 2005 to 2015; the various segments are reported at five-year intervals for 2010 and 2015.

This report quantifies trends in various measures of growth. Growth (or decline) expressed as an average annual growth rate (AAGR) is the least squares growth rate, which takes into account all available datapoints over a period. Growth calculated as a compound annual growth rate (CAGR) employs, by definition, only the first and last datapoints over a period. The CAGR is used to describe forecast growth, defined as the expected trend beginning in the base year and ending in the forecast year. Readers are encouraged to consider historical volatility when assessing particular annual values along the forecast trend, including in the forecast year.

Key macroeconomic indicators are also provided at five-year intervals with CAGRs for the years corresponding to other reported figures. Other various topics, including profiles of pertinent leading suppliers, are covered in this report. A full outline of report items by page is available in the [Table of Contents](#).
